### CLUB PET BOARDING AGE CERTIFICATE

In order to provide the best possible care for our clients and their pets, we ask that the following documentation be submitted for our records annually stating that this pet is stable and healthy for a boarding environment. Pets over a designated age must have written veterinary clearance to board at Club Pet, a non-medical, non-24 hour facility which does not provide overnight staffing or services.

This policy applies to pets over the following ages:

**Cats > 12 years   Dogs under 40 lbs. > 12 years   Dogs 40 to 90 lbs. > 10 years   Dogs over 90 pounds > 6 years**

- Pets over a designated age must provide Age Certificate documentation annually in order to board. Club Pet management reserves the right to request documentation more frequently when deemed necessary.
- Age Certificates must be filled out individually for each pet that is subject to this policy. Please do not group multiple pets onto one form.
