

MLK Day Critter Camp Junior Volunteer Application

Thanks to Education Volunteers, the Helen Woodward Animal Center helps both people and animals by educating children about pet responsibility. The Junior Volunteer program is both fun and hard work. Volunteers must be mature, dependable, be able to follow directions, work independently, and display introductory leadership and teamwork skills. The most successful volunteers are committed, enthusiastic and experienced with children. Volunteers should have some previous experience working with children and a desire to work with $Pre K - 6^{th}$ grade.

MLK Day Critter Camp will take place on January 16th, 2017. Volunteer shifts are from **8:00am-3:30pm each day** so you must be available from 8-3:30pm each day you volunteer. There are also 2 openings from **9:00am – 5:00pm**. We cannot accommodate partial volunteer days.

Applicants must be in 9^{th} – 12^{th} grade as of Fall of 2016. Applicants 18 or over will need to submit fingerprints prior to volunteering with children.

It is important to understand that the volunteer's job is working with children (not animals). Volunteers do prep work before and after class, clean up, assist with managing children's behavior, and supervise lunch & play time. Volunteers help the teacher with animal lessons, art, and games. Volunteers will be working around animals but not directly handling them.

You are not guaranteed a spot as a volunteer until the application has been received and you have been contacted via email or phone to confirm your assignment. If you do not receive confirmation within three days of submitting your application, please contact Laurie at 858-756-4117 ext. 370.

We will schedule a training session for **NEW volunteers only on Monday January 16th from 7am-8am** where you will receive a Volunteer T-Shirt. Please note that you will NOT be able to help without this training! Past volunteers may wear the red Critter Camp Volunteer Shirt from this past summer only. If you do not have one, we will provide you with one.
