# CLOSER & CLOSER TOBREAKING GROUND!

It has been an amazing task to raise the remaining funds for our new Adoption Facility. Although a great deal has been raised, there is still a substantial amount needed to reach our goal of \$14,000,000. In recent weeks, many people have come forward to help us reach our goal. We want to share one gift that not only surprised us, but also touched us deeply. A gift from a trust fund created by old friends back east, The Alex and Elisabeth Lewyt Charitable Trust, managed by Wendy McColgan and Thomas Amlicke.

Wendy and Tom are responsible for a fund started by the Estate of Elisabeth Lewyt to provide for the care of companion animals in need. Wendy was the former assistant to our own President, Mike Arms back in New York and Mrs. Lewyt's executive assistant for many years. Tom was a trusted advisor to Mrs. Lewyt. Wendy has followed Mike's career and knew well of the amazing work being done on behalf of animals through Mike's endeavors. When the time came to consider what type of gifts she might be giving from the trust this year, she looked to Mike to find out what projects were impacting animal welfare. When he shared our plans for the new Adoptions building and the international work the Center was doing for animals, Wendy and Tom felt certain this was a project that the Lewyt's would have loved. We are honored to feature the Lewyt's photo in the lobby of the new Adoptions building as a tribute to a lifetime spent improving the quality of life for animals.

Founded in Long Island, New York in 2016 the Alex & Elisabeth Lewyt Charitable Trust is a 501(c)(3) private foundation whose mission is to continue and expand on the

Lewyt's pioneering vision of improving the lives of companion animals, reducing animal cruelty and euthanasia rates, and supporting programs for the general betterment of all animals. Elisabeth "Babette" Lewyt was committed to organizations that followed a no-kill policy for stray and abandoned pets. Together, the Lewyts were instrumental in saving countless animals from euthanasia,

both through philanthropy and hands-on work. Mr. Lewyt held patents for many inventions, but he was best known for the Lewyt vacuum cleaner. For the last 30 years of his life, he was President of the North Shore Animal League and was credited with turning it into one of the largest animal shelters in the country. As a Board Member of a number of philanthropic enterprises, including the Metropolitan Museum of Art, Mr. Lewyt often said he focused his energy into the North Shore Animal League because "my wife adores animals, and I adore my wife."

# OUR NEW ADOPTIONS CENTER

Designed in the most cost-effective manner, the Center's new Adoptions facility will utilize the same footprint as the current building. Our new design is better suited to meet the growing number of adoptable pets in our care, and by using the current foundation, it will allow for an expedited construction period, a critical detail that will limit the impact on our Adoptions program.

The new building's design has a separate entrance and private hallway for our rescue partners to unload animals and meet with our staff and veterinarian. The hallway leads into a surgery suite and an area for exams with multiple surgical tables. This large space allows the veterinarian and our veterinary technicians to perform exams simultaneously and accommodates the large numbers of spay/neuter procedures that must be done.

The dog kennels will be in a pleasant, aesthetically pleasing, courtyard-type area that should encourage longer and more frequent visits from guests looking to adopt. Kennels will be fully covered offering protection from cold winds and rains in the winter and the scorching heat in the summer. In addition, they will be easier to clean and will require less staff time to keep sanitized and ready for the next adoptable pet. The feline area has plenty of light and ample room for the cats to spread out and interact with each other and their visitors.

Ground-breaking on the new Adoptions center is slated for September 2017. Adoptions will still be open, but to ensure everyone's safety, we will be moving our adoptions to another location on the Center's property so we can continue our life-saving work during construction.

The next trip on our roster is to Puerto Rico to work with Michelle Cintron who has been instrumental in helping us to get the local schools on board with Remember Me Thursday<sup>®</sup> curriculum. Last year, the students created an amazing "homegrown" video sharing what their pets mean to them and sent a powerful message about the importance of rescue. Michelle has brought together over 200 animal organizations from across the island to learn how to run their rescue or shelter as a business and create the most successful outcomes for their orphan pets. We are so excited at the level of participation and for the number of groups that are coming together to learn and grow on how to help animals!

In addition to providing our vital workshop information, we will also have a special opportunity to visit the children of Culebra, off the coast of Puerto Rico. They created another special video for us and we can't wait to see the program that they put together for pet adoption awareness on our upcoming visit.

They are a wonderful group of kids who are passionate about animals and are changing the future through their hard work and commitment to sharing the message. Once again we are reminded that these children (and all of those we reach with humane education) have the power to change the world, one adoption at a time.  $\clubsuit$

### CHARLIE'S STORY

Charlie's heart raced as he ran in fear through the streets of a small town in Central California. As he darted dangerously between cars, a good Samaritan spotted Charlie and came to his rescue. She swooped him up and took him to a nearby shelter. They immediately noticed something wasn't quite right with Charlie's jaw and the unusual way his tongue hung out the side of his mouth.

Sadly, they realized Charlie's jaw had been broken, but never repaired, resulting in his unusual appearance. When Charlie came to us, he was long overdue for a trip to the dentist. We made sure to give him a thorough exam and deep cleaning of his teeth, and then Charlie was ready for his forever home.

# WORKING TOGETHER FOR ABRIGHTER FUTURE

Recently, a call for help came into Helen Woodward Animal Center from a volunteer with the Antelope Valley Dog and Cat Rescue. They were concerned about their 86 year old founder and were looking for resources to provide to her for the care of 150 animals at a sanctuary facility in the high desert. We felt that the need was urgent, so we packed up and headed off to the sanctuary as soon as we could to find out what we could do to help. Upon arrival, we were surprised to find that it was a chilly 46 degrees in the middle of the day and that all of the animals were outdoors in nicely caged runs that lacked a proper roof. The founder was a lovely woman, named Vilma, who has given her heart and soul to the care of these animals and was concerned about their future given her age and limited resources.

We were pleased to find that the animals were well-cared for, and in fact, 80% of them were adoptable. Unfortunately, the population in that area would not support the rehoming effort for these animals, so we offered to provide some vital support by transferring animals back to Helen Woodward Animal Center for adoption into their forever homes. Charlie was one of these pets that made his way to the Center after his very traumatic beginning.

We have plans to continue working with Vilma to bring all the adoptable animals to the Center and rehome them to loving families. We can look forward to seeing all of them warm and cozy in their adoptive homes, instead of struggling through the brutal elements of the high desert. We commend Vilma for her hard work and dedication to these beautiful pets.



In addition to rehoming the 150 cats and dogs already in her care, the Center is working with Vilma and her family and to evaluate taking over the property. This location would serve as a place where we could provide ongoing care for unadoptable animals (due to behavioral and/or medical issues) and a halfway "house" for us to quarantine adoptable pets from other areas in Northern California.

An additional location such as this would free up space at the Center, allow us to take more adoptable pets from overcrowded shelters around the Southwest, and offer a sanctuary environment if needed. The facility would require significant renovations and staff, but we feel it would open a new opportunity for us to provide much needed vital services. The Center continues to innovate and look for new ways to help orphan pets in need through creative solutions and mutually beneficial relationships.

# AND THE HUMANE AWARD GOES TO...

IT IS WITH GREAT HONOR THAT HELEN WOODWARD ANIMAL CENTER PRESENTS 2017'S HUMANE AWARD TO CARRIE ANN INABA FOR HER LIFE-LONG, SELFLESS DEDICATION TO THE ANIMALS THROUGH HER EFFORTS AND THOSE OF HER ANIMAL PROJECT FOUNDATION.

Helen Woodward Animal Center's Humane Award is given to an individual who has as made a significant impact on the animal welfare world. Past recipients include animal lovers Kristen Bell, Diane Keaton, Betty White, and Jackson Galaxy. It is awarded to those who have dedicated their time, energy, and resources to improving the quality of animal lives, and this year's recipient is no different.

Carrie Ann Inaba was an animal lover from the very beginning. As a child growing up in Hawaii, she lived on a wildlife preserve where she was surrounded by all types of animals. In addition to her family's own dogs, cats, and fish, she has always been a loyal friend to the animals.

As Carrie Ann's career gained momentum to her present day role as a judge on Dancing with the Stars, one thing was constant in her life, her pets. Carrie Ann knew she could always count on them for unconditional love, happiness, and laughter. Rather than just limit her love to her own adopted pets, she began to extend her circle of compassion.


In 2012, Carrie Ann was inspired to found the Animal Project Foundation in honor of her longtime feline companion, Shadow. Her non-profit's mission is simple: to save lives, educate, and support animal welfare efforts. The Animal Project Foundation has given life-saving grants to rescue organizations nationwide and created numerous Spay Neuter events in the Los Angeles area. In 2015, Carrie Ann embraced the role of Official Spokesperson for Remember Me Thursday<sup>®</sup>. Not only did she film an adorable public service announcement, she created a blooper reel with her cat Mimi. To date, Remember Me Thursday<sup>®</sup> has championed pet adoption by uniting 180 countries, over 700 animal welfare organizations, and over 865 million people on social media.

In 2016, Carrie Ann enthusiastically shared photos of her own dogs for the #MySmallDogIs social media campaign. This campaign was aimed to encourage adoption of the overlooked, and abundant, smaller dogs found in shelters. Not only has Carrie Ann's support been a true gift to Helen Woodward Animal Center, but to our four-legged friends everywhere.

In addition to the Humane Award being presented to Carrie Ann on March 4, 2017 this year, Helen Woodward Animal Center has decided to present the Animal Champions Tribute Award to Jennifer and Matt Hubbard for their incredible efforts to create an animal sanctuary and programs in honor of their daughter, Catherine Violet Hubbard.

Before she was killed in the Newtown school massacre, 6-year-old Catherine Violet Hubbard raised money from returnable bottles and cans to buy bones for dogs at the pound and designed business cards for an imaginary animal shelter, listing herself as "caretaker." Her pretend animal shelter is now on track to become a reality to honor the life of the little girl who was one of 20 first-graders killed in the 2012 Sandy Hook Elementary School shooting. Plans for the sanctuary in her name include a shelter and adoption center for cats and dogs, a refuge for farm and work animals, and a rescue and release program for injured, native wildlife.



THANK YOU TO ALL OF OUR LOYAL FRIENDS AND SUPPORTERS WHO HAVE MADE 2016 THE BEST YEAR IN THE CENTER'S HISTORY FOR THE PETS AND PEOPLE WE SERVE!

The Center saw tremendous growth this year with our educational and therapeutic programs, as well as an increased impact around the world with our international campaigns. We had, yet another, record-breaking year with 3,390 orphan cats and dogs finding their forever homes and our global presence reached even more people this year with the Remember Me Thursday<sup>®</sup> and Home 4 the Holidays<sup>®</sup> campaigns. Since Home 4 the Holidays began in 1999, we have helped find homes for over 12 million orphan pets, and this year, Remember Me Thursday made over 337 million impressions on social media worldwide to honor those pets who lost their lives too soon.

The Center's Humane Education program taught respect and compassion for animals to over 13,800 children this year, including providing hands-on interactions with animals to over 100 classrooms at low income schools. Pet Encounter Therapy and Therapeutic Riding initiated over 25,000 therapeutic interactions to the children and adults who benefitted from the animals, and AniMeals supplied 350,000 meals to the pets of homebound seniors, low-income families, and military veterans. Club Pet Boarding, the Companion Animal Hospital, and Orphaned Objects Resale Shop also had a successful year, but none of this would be possible without your support. Thank you for changing the lives for so many people and pets in 2016. We know 2017 will be even more spectacular with your help.
